## PROCEEDINGS OF THE EIGHTY-EIGHTH ANNUAL ENCAMPMENT DEPARTMENT OF COLORADO & WYOMING SONS OF UNION VETERANS OF THE CIVIL WAR

June 5, 2016 Colorado Springs, CO

- 1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article III, Bylaws of the Department of Colorado & Wyoming, SUVCW, the Eighty-Eighth Annual Encampment of the Department of Colorado & Wyoming, was held on June 5, 2016, at The Academy Hotel, Colorado Springs, CO
- 2. The Encampment was called to order at 1:00 P. M. by Department Commander Gene Cheney. At that time, the encampment was opened in due form according to the Rituals and Ceremonies of the Order.

- 6. Our honored guest, National Senior Vice Commander-in-Chief, Donald Martin was introduced and gave brief comments. He conveyed the greetings of the Commander-in-Chief and passed on

- 9. Secretary Richhart reported that no communications had been received.
- 10. Commander Cheney noted that he knew of no items of unfinished business from the Eighty-Seventh Encampment and none were reported from the floor.
- 11. Commander Cheney then took up new business:
- 12. As mentioned in his report, Commander Cheney reported that Thomas E. Bowman Camp 12 voted to disband. Commander Cheney issued a department order suspending the Camp for a period of time to allow efforts to revive the Camp to proceed. If these efforts fail, the Commander-in-Chief will be requested to revoke the charter. All Brothers of Camp 12 have been issued a Transfer Form and all Camp property has been surrendered to the Department. At this point, PDC Barker and PDC Richhart assisted by PCC Ayler furled the Camp 12 colors.

- 13. Commander Cheney presented Department Awards as follows:
- a. The James E. Jewell Award for the Outstanding Recruiter of the year to PDC Eric D. Richhart (Camp 1).
  - b. The A. V. Bohn Award for the Outstanding Camp of the Year to Centennial Camp 100.
- 14. PDC Richhart brought up the plans to form an Auxiliary. Discussion ensued on whether it was preferable to have an At-Large Auxiliary in the Department or have it attached to a particular Camp. The consensus was to attach it to a Camp. All Camp Commanders and Brothers were requested to get the word out and pass contact information for any potential Sisters to PDC Richhart.
- 15. Discussion was held on the new VA rules for requesting VA headstones. Basically, having the next of kin sign the request is no longer required if certain conditions are met. The SUVCW, as a veteran service organization can act as the requester. However, information should be provided detailing efforts made to locate the next of kin. We must still follow the procedures outlined in the National Policy.
- 16. Discussion was held on the ROTC Program. ROTC medals and certificates are now free of charge if ordered by the Camp. Consensus was that the program should continue to be handled by the Camps. It was left up to the incoming Department Commander to decide if he thinks it necessary to appoint a Department ROTC Coordinator.
- 17. Commander Cheney asked if any Brother intended to attend the National Encampment. Brothers Barker, Cheney and Weart responded affirmatively. As Brother Weart was the only one of the three who was not entitled to a seat by virtue of past rank, it was moved and seconded that he be elected as a delegate. Adopted. The Commander then entertained a motion that "All Members and Associates of the Department who are in good standing as of this date and are not otherwise entitled to membership at the National Encampment nor elected as a "Delegate" shall be elected as "ALTERNATE DELEGATES" to the National Encampment of the Sons of Union Veterans of the Civil War". Moved and seconded. Adopted.
- 18. There being no more new business to come before the Encampment, Commander Cheney directed the Chaplain to close the Bible and declared a 15 minute recess.
- 19. At 2:30 PM, the encampment was reconvened and Commander Cheney proceeded with the nomination and election of officers.

- 21. Commander Cheney asked for a motion that where an office is unopposed, the Secretary be instructed to cast a single ballot in favor of those candidates. Moved and seconded, Adopted.
- 22. There being no further nominations from the floor, it was moved and seconded that the Secretary cast one ballot for all unopposed nominated candidates. Motion passed and all candidates were declared duly elected.
- 23. At this time, Commander Cheney turned over the gavel to National Senior Commander-in-Chief Martin for the installation of officers.
- 24. Commander-elect Bill Salmon was asked to provide a list of appointed officers. The following list of those elected and appointed, was read:
